\$PRPTY is a compliant equity security token representing ownership in Land Invest Corp. Each token provides investors with exposure to the company's U.S. land portfolio, revenue streams, and quarterly profit distributions.

LandInvest.io operates a vertically integrated real estate investment model focused on the acquisition, improvement, and resale of undervalued U.S. land parcels—primarily sourced through tax-defaulted and distressed property auctions. By combining strategic land acquisitions with blockchain-based fractional ownership, Land Invest Corp converts tangible assets into regulated digital securities through its \$PRPTY token.

Investors gain direct equity in the company and its underlying land portfolio, benefiting from both quarterly profit distributions and long-term appreciation. The company also generates recurring revenue from its subscription-based marketplace, BuyVacantLand.com, creating a diversified income stream that supports sustainable growth and investor returns.

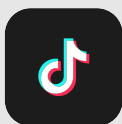

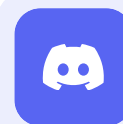
